



THE CHALLENGE


Health Departments and other public agencies are responsible for addressing major challenges to health.

THREE APPROACHES

1. Share students and faculty.



2. Translate results.



3. Consult early and often.

TRANSLATE RESULTS

Lipitz Public Health Policy Faculty Awards

- Donor supported award
 - 3 deadlines/year
 - \$10-\$15K/award
 - Typically complete in one-year
 - Funds awarded within 30 days after deadline
- Emphasis on projects that support the translation of research results into policy in direct support of policy development or implementation
- Require that faculty engage a key decision-maker or policymaker as a partner and "principal knowledge user" in support of translational efforts




TRANSLATE RESULTS

Bloomberg American Health Initiative Dissemination Awards

- Annual awards of ~\$10K-\$20K
- Emphasis on getting evidence in a usable form and widely sharing it with to research end users
- Recently completed research
- Dissemination activities only
- briefs, websites, vidoes, infographics, etc.
- Monitor reach



Program to treat opioid addiction in ACI called a national model

Pioneering approach to addiction in Rhode Island jails saves lives

Raimondo: Overdose deaths in R.I. drop 9 percent





- 2017: Borough President's Office concerned about highest rate of drug overdose in New York
- Lots of work happening but key question: are we focused on the right things?
- Plan: develop a data strategy to align response efforts



- Requires letter of support from public sector official
- Initial projects: food policy in Baltimore, maternal mortality in New Jersey, employment opportunities for individuals in recovery in West Virginia

- The most successful projects involve early engagement with the public sector and joint development of ideas.


